**Overview**

This Action Plan Modification pertains to the reprogramming of portions of the \$5.058 billion allocation in Community Development Block Grant (“CDBG”) funding from the U.S. Department of Housing and Urban Development (“HUD”) as part of the \$5.48 billion federal appropriation through the Emergency Supplemental Appropriation Act for Defense, the Global War on Terror, and Hurricane Recovery, 2006 (Public Law 109-148) and to the additional use of portions of the \$423,036,059 allocation in CDBG funding from HUD as part of the \$5.48 billion federal appropriation through the Emergency Supplemental Appropriation Act for Defense, the Global War on Terror, and Hurricane Recovery, 2006 (Public Law 109-234). These monies have been designated by Congress for “necessary expenses related to disaster relief, long-term recovery, and restoration of infrastructure in the most impacted and distressed areas related to Hurricanes Katrina, Rita, or Wilma.” These funds are being administered by the Mississippi Development Authority (“MDA”) for the State of Mississippi.

**Background**

Pursuant to the above captioned Public Laws and implementing CDBG waivers and alternative requirements issued by HUD, MDA issued its first Partial Action Plan in March of 2006, which created the Homeowners Assistance Program designed to provide Mississippi’s Coastal residents recovery grants based on the damage inflicted on their home by Katrina’s storm surge. Since that time, MDA has issued numerous partial action plans to address various vital aspects of recovery, including the rebuilding Mississippi’s devastated economy. In this effort, on December 15, 2006, HUD accepted MDA’s Economic Development Program Action Plan (Amendment 4 Partial Action Plan)(“ED Action Plan”), outlining the severity of destruction to the state’s economy as a result of Hurricane Katrina and providing various loan and grant programs to address those needs.

The story of Mississippi’s recovery has been one of great progress to date. Because of an essential emphasis on housing, the state’s affordable housing stock now exceeds pre-Katrina levels. Furthermore, with the establishment of the new Neighborhood Home Program (Long Term Workforce Housing Action Plan, Amendment 6 Modification 3), the remaining damage to homes of low to moderate income citizens is being addressed in an unprecedented fashion.

However, despite the best efforts undertaken by the various ED Action Plan programs, the Mississippi Gulf Coast has not yet returned to pre-Katrina employment numbers. Hindering the renewal here have been the twin obstructions of the greatest economic collapse since the Great Depression and the BP oil spill disaster. Therefore, six years after the storm, the most critical
